## CLINICAL INSTRUCTOR CERTIFICATE COURSE: REGISTRATION FOR JANUARY 2014 OPENING SOON !

<u>Course Description</u>: This five-week course will encompass clinical education at the baccalaureate level in acute care settings and public health/community health care placements.
