She began her nursing education career at Saskatchewan Polytechnic and spent five years teaching and working in curriculum development, before assuming a leadership role in the Institute for Nursing Scholarship. In that position, during her final year, she supported the scholarly work of nursing faculty including the development of research grants, publications, conference abstract submissions, and presentations. Dr. Risling has continued to engage in curriculum work at the University of Saskatchewan in addition to developing a patient-oriented program of research in health informatics. This work includes study on social media, the development and evaluation of patient-centered technologies, and patient access and use of electronic health records. Balancing this research work with her administrative duties as the newly assigned Curricular Chair for the College has provided a strong foundation of experience to support a meaningful contribution to the work of CASN.
