**Clinical Placement Coordinator - Nurse Practitioner Program  
Permanent Position**

Memorial University is the largest university in Atlantic Canada. As the province's only university Memorial plays an integral role in the education and cultural life of Newfoundland and Labrador. Offering diverse undergraduate and graduate programs to almost 18,000 students, Memorial provides a distinctive and stimulating environment for learning in St. John's, a safe and friendly city with great historic charm, a vibrant cultural life, and easy access to a wide range of outdoor activities.

The Faculty of Nursing is located on the university campus and offers programs leading to a Bachelor of Science in Nursing (four-year and accelerated options), a Master of Science in Nursing (practicum and nurse practitioner options), a Post Master's Nurse Practitioner Graduate Diploma, and a PhD in Nursing.

Memorial University Faculty of Nursing invites applications for a full-time clinical placement coordinator. This position will be responsible for coordinating clinical placements in the Nurse Practitioner program. This is an Academic Staff Member position reporting to the Associate Dean of Graduate Programs.

The Clinical Placement Coordinator will work in collaboration with faculty, all of whom report to the Dean of Nursing, in all programs offered at the Faculty of Nursing, including the BScN (Collaborative) program and the MScN Nurse Practitioner programs. Some travel may be required within the province. The Clinical Placement Coordinator works closely with the Associate Dean of Graduate Program's team, and may be assigned other work related to the graduate program, as required. Duties for this position include:

- Obtain clinical placements and preceptors for nurse practitioner students, and may be assigned to be the instructor of a preceptored course.
- Uses designated software to coordinate clinical placements and preceptors, and serves as the lead for implementing and monitoring software at the Faculty of Nursing.
- Works with clinical placement coordinators at other sites/schools of the undergraduate program, and may be responsible for clinical placements and preceptors for specific courses for the St. John's sites.
- Collaborates with the NP Program Coordinator to facilitate the monitoring and evaluation of NP students.
- Recommends and monitors student funding for clinical placements.
- Works with health care organizations and the university lawyer/risk management to develop and obtain clinical placement agreements, and recommends these agreements to the Dean.

- Provides in-services related to student placements to nurses and preceptors at clinical sites in collaboration with other faculty members.
- Reviews the clinical competency of students throughout the program and strategically matches students to optimal learning experiences.
- May be involved in special projects that enhance the delivery of clinical education in the Graduate Programs at the Faculty of Nursing.

Applications are welcomed from individuals with a Bachelor of Nursing and a Master of Nursing who have a minimum of five years experience in professional nursing practice. Ideally, the candidate should also have experience in HSPnet or other computer software for clinical placements, direct nursing practice, and clinical instruction in training/course delivery.

**All successful applicants must hold a current practicing license with the College of Registered Nurses of Newfoundland and Labrador (CRNNL) as a Registered Nurse or Nurse Practitioner; provide a criminal records screening and vulnerable sector check; and an up-to-date immunization record.**

Applicants should include: a letter which outlines relevant work experience and fit for the position, a curriculum vitae, and names and contact information (including email addresses) of three current references.
